Answering the Questions of Perinatal Illicit Substance Exposure

articipants will attend an educational offering regarding substance exposure in the neonate. The offering will be composed of information related to those items as identified by Zellman "important decision points, key diagnostic criteria and screening tools, encourage communication among medical personnel,... referral

and reporting" (2002, p206).

he educational session will begin with a discussion of the current state of neonatal substance exposure from a national and state perspective. Referral to the Healthy People 2010 goal of 100% abstinence of illicit substance use during pregnancy will be emphasized. Recent statistics for the project state will be shared, and include the financial impact of neonatal substance exposure.

T

uidelines for heightened awareness and further assessment of possible substance exposure will be shared, with reference to both maternal and neonatal indicators. Commonly used methods of substance detection will be discussed. Four specific illicit drugs and categories will be examined: marijuana, cocaine, methamphetamine, and opiates. The action of the specific drug, placental transfer, delivery issues, physical symptoms of exposure, withdrawal symptoms, reported long term outcomes, and breastfeeding implications will be examined. Neonatal abstinence syndrome, along with a commonly used assessment tool, will be explored.

- 3) Identify signs and symptoms of Neonatal Abstinence Syndrome.
